GLA offers new interactive video classes

Great Lakes Aquarium is now offering interactive videoconferencing opportunities to students throughout Minnesota and beyond! This new program is known as 'The Gitchi Gummi Connection' and offers classes on



freshwater topics from aquatic invasive species to culvert design and engineering. The program uses technology similar to Skype or Facetime, which allows students to interact in real time with presenters right from their classroom. One popular class, entitled 'Urgin for Sturgeon,' engages students in grades K-2 with North America's biggest freshwater

fish, the sturgeon. Students in this class learn about this incredible fish by 'building' a sturgeon with their bodies, talking with Sturgeous Caturgeous (a large sturgeon puppet) about 'growing up sturgeon,' and joining SCUBA divers as they dive into Great Lakes Aquarium's biggest tank to hand-feed the sturgeon. Stream restoration projects are underway

The City of Duluth has sixteen DNRdesignated trout streams within its borders, many of which drain to the St. Louis River. Efforts to restore some of the damage to Duluth's trout streams that occurred during the 2012 flood are underway. Contractors hired by the City began work on parts of Kingsbury and Mission creeks in November 2013. Stabilization of slopes and channel restoration work will begin at select locations during the summer of 2014 on Sargent, US Steel, Stewart, Merritt, Miller, Coffee, Chester and Amity creeks. This work is funded by several sources including BWSR, FEMA, NRCS, DNR and Trout

Unlimited. Limnotech is preparing restoration design plans for the western streams while Barr Engineering is responsible for design for streams east of and including Miller Creek. For more information contact Chris Kleist at <u>ckleist@DuluthMN.gov</u>.

Chambers Grove projects planned

There are a number of very exciting things happening in the near future at Chambers Grove Park in the Fond du Lac neighborhood of Duluth.

St. Louis River Hiking Trail - The City will restore and improve this flood damaged hiking trail with its outstanding vistas of the St. Louis River corridor and unique ravine crossings. The trailhead is in Chambers Grove and the trail will run along the river up to the Fond du Lac dam (but not actually on Minnesota Power property), and connect to the existing trail system in that area of Hwy 210.

COGGS trailhead - Chambers Grove is the western terminus of the Duluth Traverse Trail, a shared project with the City and COGGS to build a continuous network of multi-use trails across the entire 27 miles length of Duluth. This effort alone brings this community park into Regional Park status.

Storm Water Management System - \$99,900 funding for reestablishing and improving the flood damaged storm water management system has been awarded the City through a \$250,000 grant from the Great Lakes Shoreline Cities Green Infrastructure Grant. Engineering design will be done inhouse at the City with implementation in 2014.

Chambers Grove Park Flood Damage Restoration and Improvements -Minnesota DNR's Parks Legacy Grant Program has awarded the City of Duluth \$1 million toward the flood damage restoration and improvements to Chambers Grove. River Restoration efforts of the Minnesota DNR includes the design of the sheet pile removal, restoration of the shoreline and integration into the upland park improvements.

On Saturday, February 15th from 1:00-3:00 pm, SLRA will host a "Winter Walk on the River" featuring the Grassy Point area. This walk will be at the Grassy Point Trail parking area (end of Leisure St located just off the Waseca Industrial Ave in West Duluth.

Come join us for a unique winter adventure on the St. Louis River. Exploring the river in its solid form can be an especially fun experience for people who primarily view the river from the shore. The route will include visiting sites of former saw mills in the Grassy Point area as well as other ruins nearby. Learn about the historic industry that was in this area as well as news about a project to improve the habitat that will be underway soon.

This activity will involve walking on snow-covered ice as well as through some brush and grass. Participants will need to bring their own skis, snowshoes, or just some good warm winter boots. Note: The amount of snow so far this winter make skis and snowshoes the better options.
