








## The Area of Concern Program



The **1987** Great Lakes Water Quality Agreement established **43** of the most polluted locations on the Great Lakes.

These "Areas of Concern" are the focus of comprehensive cleanup and restoration efforts.

Others provide administrative, technical, and outreach support



















## The Area of Concern Program

The St. Louis River AOC Boundary









**Problem:** Contaminants left behind from historic industrial discharges threaten human health and the environment.

Project Objectives: Remove legacy contamination, restore aquatic habitat, and improve recreation access.



## Munger Landing (MN/WI)

## 2022 Work:

- ✓ Dewatering facility and water treatment systems constructed
- ✓ 79,000 CY of contaminated sediments removed/disposed

### 2023 Work:

- Dredge/dispose of remaining sediment (21,000 CY)
- Place clean cover material
- Restore nearshore fish habitat
- Restore upland vegetation
- Construct kayak landing
- Restore boat launch and parking lots

## Perch Lake (MN)

**Problem:** Perch Lake is isolated from the main river channel by Hwy 23.

- > sediment is high
- oxygen is low
- habitat is poor

Project Objectives: Restore coastal wetlands, deep water, spawning habitat, marsh bird habitat, and hydrologic connection.







Phase 1 (2022-23): Dredging

Phase 2 (2023): install culvert under highway

- > 135' long + 48' aprons = 183'
- > 34 sections
- > 1.4 million lbs (700 tons)!

Phase 3 (2024): install opening under city trail




## Manoomin (MN/WI) led by WDNR

**Problem:** once abundant, manoomin (wild rice) had been nearly eradicated in the estuary.

## **Project Objectives:**

Implement the Wild Rice Restoration Plan with a goal of restoring 275 acres.





## Manoomin (MN/WI) led by WDNR

## 2023 Work:

- Install goose exclosures
- MN/WI goose management
- Harvesting, seeding, and monitoring
- Complete Restoration Plan update

## **Pickle Pond Remediation to Restoration**

**Problem:** degraded habitat caused by industrial use, stormwater runoff and lack of water circulation

Project Objectives: work with landowners and City of Superior to restore habitat for fish and wildlife, remove contamination






# Pickle Pond Remediation to Restoration Construction in 2023

- Removal of 16,500 CY of contaminated sediment
- ~17 acres of habitat enhanced and restored
- Deepen areas of the pond for fish habitat

Create additional openings in the RR grade for

better water/oxygen circulation

- Shoreline habitat features
- Wetland creation
- New stormwater infrastructure


#### March 2023: St. Louis River Area of Concern Updates

Many projects are happening to help clean-up and delist the St. Louis River Area of Concern. Current project updates for March 2023:

- Perch Lake Update | In-water work at Perch Lake is complete now that dredging between Hwy 23 and the Waabizheshikana Trail (Marten Trail) is done.
- Munger Landing Update | J.F. Brennan is working ten-hour days intermittently this winter removing contaminated sediment from the Snively Creek wetlands just south of Munger Landing.
- The St. Louis River Area of Concern: From a Fond du Lac Perspective (Event) |
  Tuesday, April 4th from 5:30-7:30 p.m. at Black Bear Casino in the Stoney Brook Creek Room












# **2023 Project Work Ponds behind Erie Pier and Scanlon Reservoir**
