

Piping Plover Project Begins 2nd Season with Renewed Hope

The St. Louis River Alliance will begin monitoring the beaches in search of piping plover this week. Monitors will look for nesting behavior at several locations on Minnesota Point and Wisconsin Point. They kicked off their 2nd season at the Earth Day event at the Marine Museum and taught students at the Stowe Elementary Environmental Education Resource Fair on April 25th.

Supported by a five-year grant from the US Fish and Wildlife Service, this project will help attract, monitor and protect these critically endangered shorebirds in the Twin Ports region. Fewer than 70 pairs of piping plovers nest around the Great Lakes, mostly in Michigan and Wisconsin. None have been known to nest in this area for over 25 years, but this project aims to change that soon.

In December a beach restoration project was completed at the Wisconsin DNR Wildlife Sanctuary to provide a safe and suitable habitat for piping plover. This area will be maintained and monitored by SLRA staff and volunteers. Partners of the project and SLRA staff are very hopeful that this restoration, the outreach efforts, and protection that will be provided will allow the birds the space and safety they need to begin to choose the Twin Ports area as their nesting grounds again.

St. Louis River Alliance is looking for volunteers to help monitor the beaches.

St. Louis River AOC Progress Report

The St. Louis River Alliance has published a first-ever report of progress for the St. Louis River Area of Concern. This progress report, written with input from many agencies involved with the AOC efforts, highlights the achievements and progress that has been made to address the issues that caused the St. Louis River to be designated as an Area of Concern (AOC) on the Great Lakes. This report was made possible through GLRI capacity funding from the MN Pollution Control Agency.

Save the Date! Climate Adaptation Workshops

On June 19th and 20th the St. Louis River Alliance will host "A Flood of Options: Adapting to a Changing Climate" 2 separate free workshops about adapting to a changing climate, with a special focus on backyard actions that can help protect local streams from damage during extreme weather such as last year's flooding. Dr. Mark Seeley has been confirmed as a speaker. The workshops will be held from 6:00-8:30 pm on Wednesday June 19th, and a repeat session on Thursday, June 20th at 1:00-3:30 in two different locations in this region. This workshop is funded in part by the Coastal Zone Manaement Act, by NOAA's Office of Ocean and Coastal Resource Management, in conjunction with Minnesta's Lake Superior Coastal Program.

These workshops are a kick-off for a larger project funded by Freshwater Future in joint effort with the St. Louis River Alliance and the W.J. McCabe chapter of the Izaak Walton League to promote public involvement in advocating for climate change adaption measures that will provide future protection of Duluth's unique streams.
